Subject: Public Hearing for Maximum Proposed Property Tax Levy

BACKGROUND: On Monday, the City Council will have a public hearing for the Maximum Proposed Property tax levy, as required by State Code. Once the public hearing is closed, the City Council will take action on a resolution approving the maximum property tax levy in the amount of \$8.69880 per \$1,000 assessed, which is a change of 5.17% from last year. A City's debt service levy is not included in the maximum property tax levy, so this is why this levy rate is used (City's overall levy minus the debt service levy).

If a City is expected to exceed 2% on an annual basis, the public hearing and resolution approval is required. Growth is not a factor that is considered in the equation, and Polk City is a growing community, with growing valuations, therefore an increase of that size are not surprising.

ALTERNATIVES: Do not approve the maximum proposed property tax levy.

FINANCIAL CONSIDERATIONS: None; the Council is simply authorizing the maximum property tax levy. The actual City budget must still be approved (March 8, 2020 meeting).

RECOMMENDATION: It is my recommendation that the Council approve the maximum property tax levy at a rate of \$8.69880 per \$1,000 assessed.

A RESOLUTION APPROVING FISCAL YEAR FY 21/22 MAXIMUM PROPERTY TAX DOLLARS

WHEREAS, the City Council of the City of Polk City have considered the proposed FY 21/22 city maximum property tax dollars for the affected levy total; and

WHEREAS, a notice concerning the proposed city maximum property tax dollars was published as required and posted on the city website and city Facebook page; and

WHEREAS, a public hearing concerning the proposed city maximum property tax dollars was held on February 22, 2021.

NOW, THEREFORE, BE IT RESOLVED, the City Council of the City of Polk City, Iowa, that the maximum property tax dollars for the affected tax levies for FY 21/22 shall not exceed the following total:

Total maximum levy for affected property tax levies – \$2,469,833

The Maximum Property Tax dollars required in the total maximum levy for affected property tax levies for FY 2021/2022 does represent greater than 102% of the Maximum Property Tax dollars requested for the current FY 2020/2021 but only due to the increase in taxable valuations.

Dear MPO Funding Subcommittee:

I am writing to you in regards to Polk County Conservations request for funding from the Transportation Alternatives Program (TAP). Polk County Conservation and the City of Polk City have been collaborating over the past several years to construct a trail connector from Polk City to the High Trestle Trail. This trail connection would connect the Neal Smith Trail to the High Trestle Trail and will also provide for a unique connection to Polk City's Town Square. This project is important to the City of Polk City, our businesses, and our residents.

Although the trail connection will be completed in phases, Polk City has outlined Phase I and Phase II in the City's 5-year Capital Improvement Plan. The final phase, Phase III, which is outside of city limits will connect the trail from the corporate city limits to the High Trestle Trail. The City has made the project a priority and has made a financial commitment in future years for the construction within city limits. Furthermore, the City has received Surface Transportation Block Grant (STBG) funds for phase I of the trail connection.

The City's full contribution for construction within corporate city limits is \$958,000. As mentioned, we have been awarded STBG funds for an intersection alignment, and portion of the trail connection in FY24 in the amount of \$393,000. The City of Polk City is not requesting funding directly from the TAP program; however, we are asking for you to strongly consider awarding Polk County Conservation for the trail connection outside of city limits to the High Trestle Trail.

I would strongly encourage all of you to visit Polk City if you have not visited before. The community is surrounded by a multitude of recreational amenities. This project will only further make the community more of a recreational destination. With that I am asking for the funding subcommittee to strongly consider an application made on behalf of Polk County Conservation, with Polk City as a co-sponsor.




Calls for Service


The total calls for service for the month of January were **393**. This includes response to citizen complaints/reports, assists, self-initiated activities such as traffic stops, building checks, suspicious persons, and case follow up. Among these calls for service Polk City Officers conducted **136** traffic stops.



Cases Made


The Police Department had **23** total cases during the month of January. **22** of the cases were investigative incident reports and **1** was a traffic collision. There are **6** active investigations from this month. There was a **52%** rate of cases cleared by arrest, for investigative cases in January.





Arrests Made

The Police Department made **14** arrests and issued **40** citations and **123** warnings. The arrests consisted of **2** drug related offenses, **10** driving offenses, **1** for Child Endangerment, and **1** wanted person.



Notable Incidents

On January 8th at approximately 1:30 pm Polk City Police Officers were dispatched to the area of NW Polk City Drive and S. 14th Street on a report of a possibly intoxicated subject. Upon arrival, Officers contacted a 38-year-old Urbandale resident who was displaying signs of drug impairment. An investigation revealed that the subject was in possession of a hypodermic needle used to inject methamphetamine and a baggie containing a residual amount of methamphetamine. The subject was charged with Possession of Drug Paraphernalia and booked into the Polk County Jail.

On January 24th at approximately 4:30 am a Polk City Police Officer stopped a vehicle for expired registration. The driver was found to have an outstanding warrant for his arrest out of Polk County for Violation of Probation. He was also found to have a suspended driver's license. The driver was cited for Driving While License Suspended and booked into the Polk County Jail on the outstanding arrest warrant.

On January 26th at approximately 4:30 pm hrs a Polk City Police Officer stopped a vehicle for not displaying license plates. An investigation revealed that the driver, a 38-year-old Altoona resident, had been consuming alcohol and smoking marijuana. The driver also had a revoked license and was uninsured. The driver's 2 children were passengers in the vehicle. The driver was charged with OWI-2nd Offense, Driving While License Revoked, Child Endangerment, Open Container, Failure to Secure Child and No Insurance. He was booked into the Polk County Jail.

Officer Training

Lieutenant Aswegan attended De-escalation Instructor Course taught by Force Science Institute. Students learned how to effectively institute a de-escalation program in their respective departments, the scientific data on the effectiveness of de-escalation and realistic expectations of de-escalating potentially violent, mentally ill or drug impaired individuals.

Officer Delaney attended the Midwest Counter Narcotics Training Center course "Highway Drug Investigations for Patrol". This is a 24-hour course instructed by law enforcement experts in drug interdiction. Students learn how to further their abilities to intercept narcotics that are being trafficked through their jurisdictions.

Officer Aicher and Eudoris were deployed 4 times in January. All deployments were for narcotics detection.

On January 19th and 20th, Officer Aicher and K9 Eudoris were certified by Canine Tactical. The certification process started with a narcotics detection on a vehicle, immediately followed by a 1-kilometer track through rough terrain to a house where Officer Aicher and Eudoris worked together to clear and locate the "offender" inside. This certification requires Officer Aicher and Eudoris to be dedicated to training throughout the year to keep their skills sharp.



20-0020

On January 21st, a Polk City Police Officer stopped a vehicle for a traffic violation. An investigation revealed that the passenger was in possession of over 61 grams of marijuana, which is a felony in Iowa. The passenger was charged with Possession of Controlled Substance w/ Intent to Deliver and Failure to Affix Drug Tax Stamp. The driver was cited and released on a charge of Driving While License Suspended.



20-0054

On February 23, at approximately 3:35 am, a Polk City resident reported a suspicious vehicle in their neighborhood. The officer located the vehicle and initiated a traffic stop. Contact was made with the driver and officer suspected that the driver may be impaired. Upon ordering him to exit the vehicle, the driver refused to comply and fled in his vehicle.



A vehicle pursuit ensued and went into Ankeny. The driver fled from the vehicle on foot, but after a search of the area the suspect was located and apprehended with the assistance of Ankeny Officers and their K9. An investigation revealed that the suspect was in possession of 2.5 grams of cocaine, a crack cocaine smoking pipe, and over \$1,600 in cash.

The driver was also found to be under the influence of methamphetamine, cocaine, and depressants. At the time of the incident, he was on parole numerous felony theft convictions. The driver was charged with OWI-1st Offense,

Notable Cases

Felony Eluding, Possession of Controlled Substance, Interference with Official Acts, and Possession of Drug Paraphernalia. He was convicted and sentenced to serve 6 years in prison. The money was seized and forfeited over to the Polk City Police Department.

20-0068

On March 3, at approximately 2:15 pm, a Polk City resident reported a possible impaired driver traveling northbound on NW Polk City Drive into Polk City. A Polk City officer located the suspect sitting in the driver's seat of a vehicle parked at Casey's. An investigation revealed that the suspect was under the influence of narcotics. The suspect was also found to be in possession of marijuana paraphernalia and prescription medications that were not prescribed to the suspect. The suspect was charged with Operating While Intoxicated-2nd Offense, Unlawful Possession of Prescription Drugs, and Possession of Drug Paraphernalia.

20-0289

On November 4th, a Polk City Police Officer stopped a vehicle for a traffic violation. An investigation revealed that the driver was under the influence of



narcotics. She was found in possession of methamphetamine, marijuana, and drug paraphernalia. Her 11-year-old son was a passenger in the vehicle. The driver was arrested and charged with OWI-1st Offense, Child Endangerment, Possession of Methamphetamine, Possession of Marijuana, Possession of Drug Paraphernalia and Driving While License Suspended.

Notable Cases

20-0321

On December 14th, a Polk City Police Officer was dispatched to a residence for a report of a motor vehicle theft. An investigation revealed that a Polk City resident had lent his vehicle to a woman he had recently met. The 36-year-old female Des Moines resident did not return the vehicle to the owner. The officer investigated resulting in the vehicle and suspect were found in West Des Moines later in the evening. The suspect was charged with Operating a Motor Vehicle w/o Owner's Consent.

Forfeitures

Property which is illegally possessed; property which has been used or is intended to be used to facilitate the commission of a criminal offense or to avoid detection or apprehension; and property which is acquired from the proceeds of a criminal offense may be subject to forfeiture.






As a result of the Coronavirus pandemic our officers had to make major changes in our day-to-day operations and our approach in proactive criminal interdiction. Officers were required to focus their enforcement to more severe offenses. This reflected largely in traffic enforcement for minor offenses, in comparison to 2019, our traffic citations and warnings were fewer by nearly 40% while our total calls for service remained consistent with the previous year.

In 2020 the Polk City Police Department received **4,441** calls for service (vs 4519 the previous year). This number includes citizen reports/complaints, traffic stops, and other self-initiated activity. Officers took **324** cases in 2020 and responded to **48** accidents. Officers also made **156** arrests, issued **306** traffic citations, and issued **682** traffic warnings.

The Police Department had adjusted our training program throughout 2020 as restrictions and recommendations were disseminated. Even through numerous precautions, we managed to continue a quality training program for our staff. Our department was one of the first in the area to train officers on new state requirements of de-escalation and fair and impartial policing. Certifications and Training



In October Officer Aicher and Eudoris certified in narcotics detection in the USPCA Detector Trials held in northwestern Iowa. Officer Aicher and Eudoris scored 198 points out of a possible 200 points, giving them an overall rating of 98%.

Deployments

Officer Aicher and Eudoris were deployed **37** times in 2020. Of these deployments, **26** were for narcotics detection resulting in over **20** items of drug related contraband taken from the street. Eudoris also assisted local agencies in locating **2** criminal offenders.

On May 4th, Officer Aicher and K9 Eudoris were requested to assist Johnston Police Officers in locating a suspect who had been cutting off catalytic converters from numerous vehicles. The officers had located the subject, but he fled. K9 Eudoris tracked the suspect for almost a mile over various terrain, ultimately leading officers to the area where the suspect was hiding. The suspect was taken into custody. The theft of catalytic converters has been a Des Moines Metro-wide problem and one that has also affected Polk City.



On July 7th, Officer Aicher and Eudoris responded to Clive to assist officers on a traffic stop involving possible drugs. Eudoris was deployed on the vehicle and alerted to the presence of the odor of narcotics. Officers located over 7 grams of methamphetamine with a street value of over \$500. Officers also found drug paraphernalia, including items used in the distribution of methamphetamine. One suspect was arrested and charged with Felony Possession of Controlled Substance and Possession of Drug Paraphernalia.

2020 Complaints

Complaints Received by PCPD in 2020

Chief Siepker and Lt. Aswegan log all complaints made on PCPD staff. All formal complaints are logged and investigated. These are handled per PCPD policy and procedures. The content of these investigations is confidential, but the number of complaints will be compiled and listed in this section of the annual report. In 2020 there were no formal complaints filed on any member of PCPD staff.




Subject: January 2021 Monthly Report

The busiest call volume day, in January, was Friday at 13 calls per day:




Most of our calls was during the day shift, between 06:00 hours (6:00 AM) and 18:00 hours (6:00 PM) by a slim margin:

ORDINANCE NO. 2021-1200

AN ORDINANCE AMENDING THE CITY CODE OF POLK CITY, IOWA BY RESTATING CHAPTER 155 – BUILDING CODES

BE IT ORDAINED by the City Council of the City of Polk City, Iowa as follows:
Section 1. There is hereby enacted the following new Chapter 155 of the City of Polk City Code of Ordinances which shall amend and restate the Building Codes by deleting the current chapter in its entirety and inserting in lieu a revised Chapter 155 which is attached hereto by reference Exhibit "A".
Section 2 . All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.
Section 3. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.
Section 4. This ordinance shall be in full force and effect after its passage, approval and publication as provided by law.

155.01 TITLE. This chapter shall be known as the Building Codes of the City of Polk City, Iowa, may be cited as such, and will be referred to herein as the "Polk City Building Code(s)."

155.02 ADOPTION OF BUILDING CODES. The following codes are hereby adopted as, and constitute, the Building Codes of the City of Polk City, Iowa, to regulate the erection, construction, enlargement, alteration, repair, moving, removal, conversion, demolition, occupancy, equipment, use, height, area, and maintenance of buildings or structures in the City.

155.03 BUILDING CODE. The provisions of the International Building Code, 2018 edition, as published by the International Code Council, are hereby adopted, subject to the following additions, modifications, insertions, and deletions:

- 1. **Section 101.1 Title.** Delete existing text and insert: "These regulations shall be known as the Polk City Building Code, hereinafter referred to as "this code"."

Subject: 3rd Reading of Sewer Rate Ordinance

BACKGROUND: On Monday, the City Council will have the 3rd and final reading for an Ordinance related to sewer rates. The City is proposing a 6.5% increase to sewer rates, effective June 2021 (bill due July 1, 2021). For your review, city staff has put together new proposed bills so that you may see the impact to multiple different users.

For sanitary sewer, we have had some significant increases in flows to the WRA in the last 2 years. Last year we had a 15% increase, and this year we have witnessed a 9% increase. Although this is something the City is working on investigating to find the source, these increases are significant to Polk City.

As with water increases, we do have some significant sanitary sewer projects in the pipeline. Although, not as costly as water, we are looking at several studies to identify Inflow & Infiltration (I&I), replacement of pumps, and a possible sewer main lining project. Instead of significant increases, we are preparing the City for smaller, incremental increases instead.

ALTERNATIVES: Do not approve the final reading of the proposed Ordinance

FINANCIAL CONSIDERATIONS: 6.5% revenue increase

RECOMMENDATION: It is my recommendation that the Council approve the 3rd and final reading of an Ordinance related to sewer rates for next fiscal year.

Subject: 3rd and Final Reading of Water Rate Ordinance

BACKGROUND: On Monday, the City Council will have the 3rd and final reading for an ordinance related to water rates. The City is proposing a 6.5% increase to water rates, effective June 2021 (bill due July 1, 2021). For your review, city staff has put together new proposed bills so that you may see the impact to multiple different users.

In April, Des Moines Water Works is implementing a 15% increase for purchased water. Although we are able to produce some of our own water, and not purchase 100% through DMWW the increase is significant to Polk City. After review of the cash flows with PFM, it was recommended initially that the City increase water rates by 9%. However, with the increases to irrigation and the educational component that was put together last year, we were able to scale back to a recommended 6.5% increase instead.

The City is facing some major water projects in the next 2 years which include drilling a new well, water main loop on Bridge Road, a new water tower with DMWW, and painting of the existing water tower. Combined, these projects total nearly \$4 million. To avoid larger increases next year, or the following year, the City is taking the approach of smaller incremental increases instead. These 4 projects will put the City water operations in a much better place once completed.
