Polk City, City Council held a meeting in the City Hall Council Chambers with public participation in person and via phone at 6:00 p.m., March 28, 2022. The agenda was posted at the City Hall office as required by law. These tentative minutes reflect all action taken at the meeting.

4. Public Hearing

a. Mayor Karsjen opened the Public Hearing on the proposed Petition to amend the zoning restrictions of the Move located at 302 S 2nd Street at 6:02 pm. City Clerk Coffin, said that the notice was published March 18, 2022 and no comments had been received for or against the proposed petition. City Engineering Representative, Kathleen Connor provided a report. Council discussed the petition. No one was present to be heard for or against the proposed petition to amend the zoning restrictions.

City Manager Huisman said the City has plans to build one in conjunction with a new City Hall.

Coffin said no written comments had been received for or against the proposal. *MOTION*: A motion was made by Dvorak and seconded by Vogel to close the public hearing at 6:16 pm.

Coffin said no written comments had been received for or against the proposal. *MOTION*: A motion was made by Anderson and seconded by Sarchet to close the public hearing at 6:17 pm. *MOTION CARRIED UNANIMOUSLY*

e. Mayor Karsjen opened the Public Hearing on the proposal to enter into an Urban Renewal Loan Agreement at 6:17pm. City Clerk Coffin said that the notice was published March 18, 2022, and a petition had not been filed asking that the question of entering into the loan agreement be submitted to the registered voters so the City Council may proceed with the authorization of the loan agreement. Coffin said no written comments had been received for or against the proposal. Rosemary Taylor, 402 W Van Dorn addressed the Council and asked to see proposed drawings of the City Hall building, she asked what the plans are for the historical building, and asked why this was not required to go to the voters. City Manager Huisman said the City Council had a facility needs study completed last year and Council talked about restoring the historical building to its original state, taking off the lean-tos and keeping the integrity of the historical building intact for the Historical registry.

MOTION: A motion was made by Vogel and seconded by Walters to close the public hearing at 6:21 pm. *MOTION CARRIED UNANIMOUSLY*

MOTION: A motion was made by Dvorak and seconded by Walters to approve Resolution 2022-36 taking additional action on proposals to enter into Loan Agreements, combining Loan Agreements, and providing for the levy of taxes to pay the same.
 Council Members, Mayor and Staff discussed the projects and timing of the various phases of the plans.
