The lawn care company *must* provide proof of insurance for the City of Polk City's records and name the City of Polk City as an additional insured. This will include \$1,000,000 general liability and workers' compensation as provided by law. Any damage to parked vehicles or to the property (buildings, curbs, trees, windows, siding, etc.) will be the responsibility of the lawn care company. - 1) Submit a copy of current insurance coverage (declaration sheet will do) Proposals that do not include this will not be considered
- 2) All acres in the R.O.W.s & Parks must be mowed on an "as needed basis" as determined by the City of Polk City but not to exceed one time per week except for the Sports Complex and the Town Square.
